## Prescott and Russell E-Business Grant Program Guidelines

The Prescott and Russell E-Business Grant Program has been created to help business owners adapt and enhance their online sales process by incorporating a sustainable e-commerce solution into their business.

### Who Can Apply?

Prescott and Russell business owners who are researching e-commerce platforms to enhance their online business activities may apply for up to \$1,000 toward the implementation of their chosen e-commerce solution.

**Note:** The electronic solution must be a transactional solution.

### Eligible Projects are:

- New and improved e-commerce websites and shopping cart solutions that help the business facilitate online transactions for their customers.
- An e-commerce solution that moves customers away from paying by e-transfers.
- Delivered by contracted service providers, external to the applicant, and will result in a functional online store, webpage or sale process.
- Implemented and paid for, between March 15 and December 15, 2020.

### Eligible Costs include:

- Development, enhancement and expansion of an online marketing/sales platform;
- Domain acquisition, hosting fees, initial or start-up licensing/ subscription fees;
- Graphic design and digital marketing assets necessary to design, enhance, and promote a professional online store, such as professional product images or paid
- Advertising to promote the new e-commerce capabilities.

## General Conditions

### The Applicant Must:

- Be a legal entity/operating business in Prescott and Russell
- Be the majority shareholder if the business is a corporation
- Maintain a separate business bank account, follow government rules and regulations for operating a business in Ontario
- Be a Canadian citizen or permanent resident
- Be over 18 years of age
- Provide a copy of one of the following pieces of identification:
  - Birth certificate, passport, driver's licence
- Provide a copy of one of the following business records:
  - Master Business Licence
  - Federal Business Identification Number (HST/Payroll account)
  - Articles of Incorporation

The individual who signs the application form must be a person who is authorized by the legal entity to sign the form on behalf of the legal entity and to bind the legal entity to the contents therein.

### What types of businesses are ineligible?

Businesses that are not eligible for funding include those that are:

- Franchises, commissioned sales and distributorships
- Not-for-profit or charitable enterprises
- Multi-level marketing ventures
- Single event organizers

### What types of projects are ineligible?

Projects that are not eligible for funding include those that:

- Support ongoing operating costs associated with carrying out business.
- Are being funded by other government programs for similar activities.

### Can I submit more than one application?

No. Applicants may be approved for one project only.

### How do I submit an application?

Applicants may apply for a Prescott and Russell E-Business Grant up to \$1,000 through an [online application form](#).

**How will I be notified of funding decisions?**

The applicant will be notified by email once an application has been reviewed and a decision has been made.

**There are two possible outcomes:**

1. The application is approved - the applicant will receive a notification of approval and details for next steps.
2. The application is declined - the applicant will receive a brief explanation for the decision.

**Evaluation**

Applications will be reviewed and assessed on a first-come, first-served basis. Applications will be submitted to an evaluation committee following a transparent process.

**When is funding paid?**

Approved funding is paid after the successful applicant has:

- a) incurred and paid for expenses, after March 15, 2020 ;
- b) implemented a functional and transactional e-commerce solution.

When project requirements have been met, the applicant can submit an Expense Claim.

Before receiving a grant payment for expenses paid - all Expense Claims, supporting documentation and proof of payment receipts must be emailed to: Geneviève Bougie at [gbougie@prescott-russell.on.ca](mailto:gbougie@prescott-russell.on.ca) for verification and confirmation that a suitable e-commerce solution has been implemented.

You will receive an acknowledgement of receipt within three days of sending a refund request.

**Request for reimbursement****What your Expense Claim package must contain:**

- Confirmation the e-commerce solution has been implemented;
- Copies of all paid invoices;
- Proof of payment receipts;

Proof of payment must verify who paid, who received payment, the amount and date of the payment.

**Examples of proof of payment may be:**

- Copy of front and back of cancelled cheque;
- Electronic image of processed cheque;
- Statement from banking institution indicating to whom the processed cheque was written, or electronic payment made, and for what amount;
- Credit card or debit card receipts or statements clearly identifying amounts and to whom the payment was made (please blackout any unrelated information);

**How is an Expense Claim submitted?**

Expense Claims should be emailed to Geneviève Bougie at [gbougie@prescott-russell.on.ca](mailto:gbougie@prescott-russell.on.ca) no later than December 15, 2020. PREDT reserves the right to request additional information from the applicant that is deemed necessary.
