

NOTICE OF PUBLIC MEETING

The Corporation of the United Counties of Prescott and Russell and The Nation Municipality will hold a statutory **electronic public meeting on October 26, 2020, at 6:00 pm** to consider an application for approval of a draft plan of subdivision under Section 51 of the Planning Act (file No. **070-S-20-004**) and to obtain public comments.

BE ADVISED that the United Counties of Prescott and Russell considered this application to be complete on **October 6, 2020**.

In order to support ongoing efforts to stop the spread of Covid-19, the public meeting will be live streamed on our YouTube Channel named "The Nation Municipality / La municipalit  de La Nation." The link to our YouTube channel is on the municipality's website: www.NationMun.ca. By participating virtually on YouTube, we can ensure everyone's safety and well-being. Due to social distancing guidelines, we have space for only seven (7) members of the public in the Council chambers – these spaces are reserved for those who do not have access to the internet. The number of spaces available are subject to the Eastern Ontario Health Unit's guidelines and may change at any moment, depending on the regional status of Covid-19.

Any person may participate in the electronic public meeting and/or make written or verbal representation either in support of or in opposition to the proposed amendment by forwarding their request to the Municipality of The Nation before **4:00pm on October 22, 2020**. It is possible to submit a question or comment during the live stream via the live chat on YouTube.

ANY PERSON may also make written representations by mail or via email to the Planning and Forestry Department of the United Counties of Prescott and Russell either in support or in opposition to the proposed development before **November 13, 2020**, at the address below. Please refer to the file number in all correspondence.

PURPOSE - The application for approval of a draft plan of subdivision comprises 260 residential units (50 for single detached dwellings, 126 semi-detached dwellings and 85 multiple units, such as townhouses), 1 block reserved for high density residential units (an apartment building) and 2 blocks for commercial uses. The affected property is located in the Village of Limoges just north of Savage street and described as being a Part of Lot 30, Concession 1 in the former Township of Cambridge. Access to this development will be provided via Savage street.

IF A PERSON or public body does not make oral submissions at a public meeting, if one is held, or make written submissions to the United Counties of Prescott and Russell in respect of the proposed plan of subdivision before the approval authority gives or refuses to give approval to the draft plan of subdivision, the person or public body is not entitled to appeal the decision of the United Counties of Prescott and Russell to the Local Planning Appeal Tribunal.

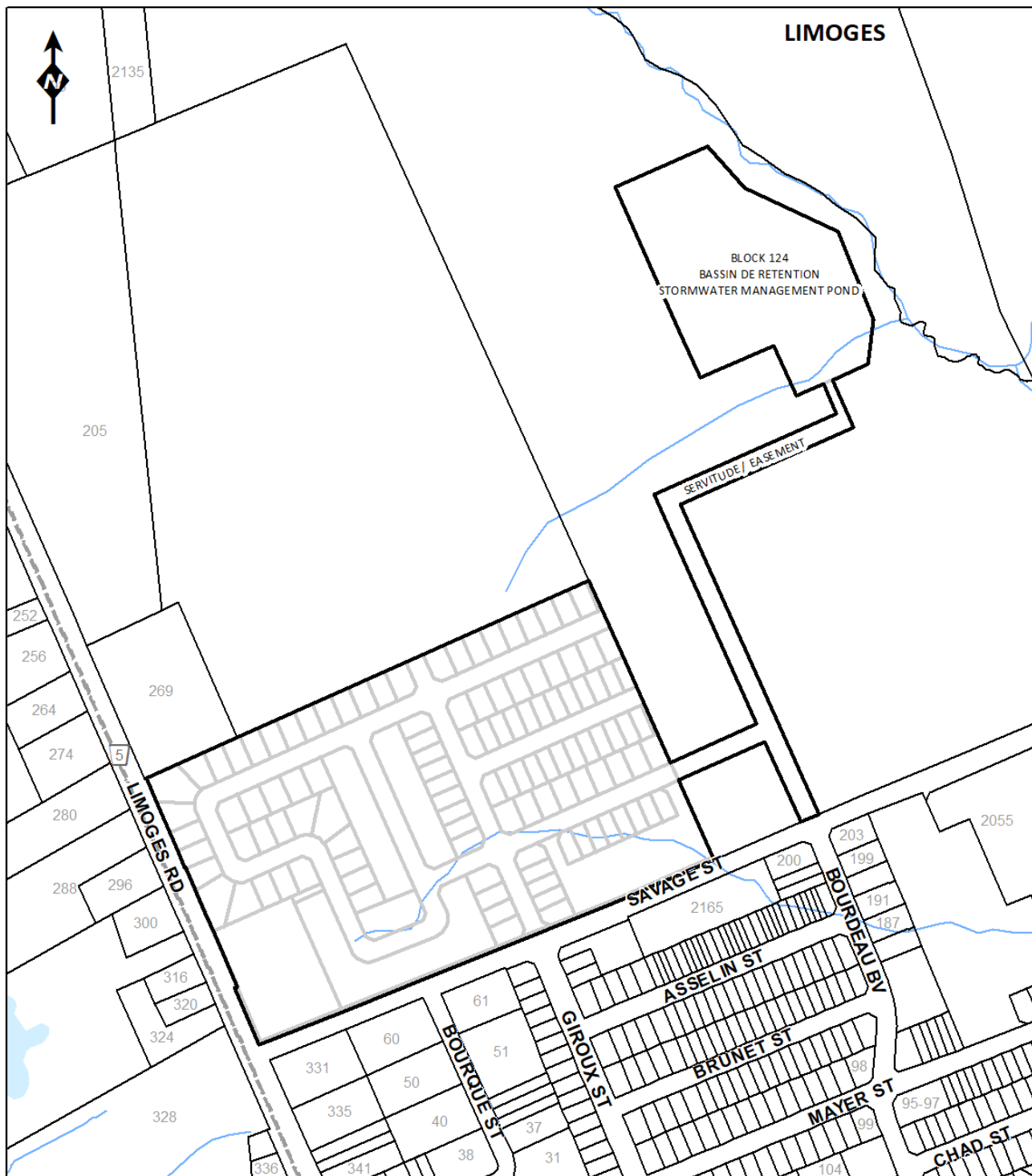
IF A PERSON or public body does not make oral submissions at a public meeting, if one is held, or make written submissions to the United Counties of Prescott and Russell in respect of the proposed plan of subdivision before the approval authority gives or refuses to give approval to the draft plan of subdivision, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
